IN SUMMARY; This is an 018th district tactical unit arrest onview by bt.'s 1860,1869,1864a & 1869d. R/o's, while assigned to crowd control at the Sheffield Garden Walk, ordered the offender to leave the area as the event had concluded. Offender became loud and pushed Sgt. R. ZAWIS#770 with his bicycle causing him to fall against a brick wall resulting in injury. Offender placed into custody after a brief struggle in which he refused to submit to being handcuffed. Minimal force necessary to effect this arrest was exercised.
