AFFIDAVIT FOR CRIMINAL OFFENSE

PERSONALLY CAME BEFORE ME, DETECTIVE BRUCE CORDIVARI, DEPUTY SHERIFF, COLLIER COUNTY SHERIFF'S OFFICE, NAPLES, FLORIDA, who, being by me first duly sworn, deposes and says that on the 20TH and 21ST day of November, 2016, in Collier County, Florida, one white male, JON DOUGLAS PARRISH, date of birth 7/31/63, did commit;

- FALSE IMPRISONMENT, in violation of Florida State Statute 787.02-1a;
- TAMPERING WITH OR HARASSING A WITNESS, VICTIM, OR INFORMANT, in violation of Florida State Statute 914.22-1e;
- DOMESTIC VIOLENCE BATTERY, in violation of Florida State Statute 784.03-1a1; 741.28(3).

Your Affiant's probable cause is based on the following facts:

- 1. The offenses occurred on 11/20/16, between 2015 and 2230 hours, at 5780 Spanish Oaks Ln. This is the residence which the victim, Eleanora Paulsen, shares with her live-in boyfriend, suspect Jon Parrish.
- 2. The victim and suspect Jon Parrish are boyfriend / girlfriend (engaged) who live together where the incident occurred. The other involved party is Natalie Peysina. Peysina is Parrish's ex-girlfriend and current business partner. Peysina has been arrested and charged for her actions in this case. The victim has been receiving hateful, harassing, and sometimes threatening text messages from Peysina for well over a year. The victim said the threats have increased in recent months since she and Parrish became engaged. Your Affiant has had the opportunity to view many of those text messages. Peysina's multiple threating and harassing messages fill the entire screen of the phone. In almost every series of text messages, Peysina repeatedly refers to the victim as a "cunt", "prostitute",

"cockroach", "freak", and "BDSM mistress" (referring to sadomasochistic sex). The messages continue with more insults and threats that Peysina will have the victim arrested, take legal action against her, and ruin her business and professional reputation. Eventually, the victim said Peysina threatened to do bodily harm to her face. The victim very rarely responds to Peysina, and when she does the victim's responses are very brief and almost always to tell Peysina to stop contacting her and to leave her alone. The victim told Your Affiant she has had to change her phone number twice in the past year, but Peysina gets her new number each time.

- 3. On 11/20/16, around 2015 hours, while the victim and her fiancé Parrish were lying in bed, Peysina arrived unannounced and entered the residence, came into the bedroom, and proceeded to jump the victim in her bed and beat her. During the initial struggle, the victim, who was naked from the waist down, was struck by Peysina in her vagina as she made lewd comments to the victim about it. The victim said Peysina was able to maneuver the victim to where she was mostly face down during the attack, with Peysina sitting on her legs to restrain them, then holding the victim's hands behind her back while she was being punched and kneed about the head, face, and body.
- 4. During this prolonged battery on the victim, who was screaming for help, suspect Jon Parrish stood by and watched, and did nothing to help the victim. Parrish's 17-year old daughter was also in the house during the attack, and did nothing to help. The victim said Peysina choked her out and she lost consciousness more than once, while Peysina told the victim in Russian that she was going to kill the victim. (The victim is Ukrainian, the suspect Russian, and both speak and understand the Russian language). The victim told Your Affiant that during the battery she was in fear for her life, and she felt that Peysina would kill her. The victim initially thought the attack lasted about 15 minutes, but was later able to recollect and determine that between the start of the attack and her regaining consciousness at least an hour had passed.
- 5. The victim said after the attack ended and she regained consciousness and tried to process what had just occurred, she asked Parrish why he didn't do anything. Parrish told the victim that it wasn't that bad, she just had a few bruises. The victim told Parrish she wanted to report the attack to the sheriff's office. Parrish told her she did not want to do that because if she did, "It will get worse for you". The victim said Parrish told her she was safe now. The victim felt that when Parrish told her "It will get worse for you", if she reported the incident, that was a direct threat to her that he would allow or cause the beating to happen again. This threat resulted in delaying or preventing the victim from reporting the attack. This is in direct violation of Florida State Statute 914.22-1e, Tampering with or harassing a witness, victim, or informant. As per the elements of the statute, Parrish clearly and knowingly used intimidation and threats against the victim, with the intent to cause her or induce her to hinder, delay, or prevent the communication to a law enforcement officer or judge of information relating to the commission or possible commission of an offense.

- 6. Your Affiant asked the victim if during the attack she saw Parrish at all. The victim said she remembered looking for Parrish at some point and seeing him standing in the doorway. Your Affiant asked her what he was doing, and she replied, "Nothing." Your Affiant asked the victim where Parrish's daughter was. She believed Parrish's daughter was in her room. Your Affiant asked the victim if she thought Parrish's daughter would have known what was happening, and she said she believed so, since the victim was screaming for help during the attack.
- 7. The victim also relayed to Your Affiant additional details of what happened just after the attack on her. When the victim regained consciousness, she noticed that Peysina had left the residence. The victim got out of bed, and Parrish made her come back in the bed. Parrish held her close in an effort, she believed at the time, to comfort her because she was shivering and scared from what just happened. Parrish was very sexually excited and tried to have sex with the victim. She told Parrish he was out of his mind to think they were going to have sex. Parrish then masturbated next to the victim. When he climaxed, he ejaculated onto the victim, then rolled over turning his back to her. By Parrish ejaculating on the beaten and battered victim without her consent, Parrish actually and intentionally touched her against her will, meeting the element of Domestic Violence Battery, under Florida State Statute 784.03-1a1; 741.28(3).
- 8. Shortly after the attack ended, the victim sent a series of emails to the Collier County Sheriff's Office email site, which included numerous screenshots of the aforementioned text messages from the suspect, as well as photos she took of her injuries and a large clump of her hair. The photos clearly depict the bruising and abrasions on her face and neck, and there is clearly redness and bruising on her neck consistent with her account of the attack and being choked. The first email was titled, "For the record", in the subject line, and the message read, "I am scared to leave my home. I will be in the office tomorrow. I am sending this in case if they take my phone. I was told I am safe now" (referring to what Parrish had previously told her).
- 9. The victim stated that the following day, Monday, 11/21/16, Parrish kept a very close eye on her. According to the victim, Parrish has surveillance cameras throughout the house which he monitors closely when he is not there. She believed that Parrish was afraid the victim was going to report the incident. The victim felt she was not free to leave.
- 10. The victim believed she was not free to go to the police the day after the incident, and suspect Parrish made it a point to keep control of the victim throughout the day, even driving her around with him from around 0930 hours until around 1500 hours. The victim told Parrish throughout the day, as well as the night of the attack, that her head was hurting and she wanted to go to the hospital. However, Parrish refused to take the victim for medical treatment, perhaps concerned that the incident would get reported to law enforcement. While driving the victim around all day Parrish would have had multiple opportunities to take the victim for medical treatment and/or to make a police report. These actions are in violation of Florida State Statute 787.02-1a, False imprisonment. As

- per the elements of the statute, suspect Parrish did, by threat, restrain another person (victim Eleanora Paulsen) without lawful authority and against her will.
- 11. In the afternoon, Parrish wanted to spend time with his daughter when she came home from school. The victim told Parrish she needed to go get a cup of coffee at Starbucks and she would be right back. The victim left and went directly to CCSO Headquarters to make a police report, at approximately 1650 hours. The duty officer, seeing the victim visibly bruised and beaten, called for a patrol supervisor to respond. A report was generated at the scene, and EMS was called to examine the victim. The victim was subsequently transported to a local hospital. Patrol deputies at the hospital notified CID, and Your Affiant responded to meet with the victim and further the investigation.
- 12. The victim suffered multiple injuries, including contusions to the face, head, and ribs; a possible concussion; a herniated disc; and had clumps of hair pulled out of her head.
- 13. On 11/23/16, Your Affiant and other CID detectives went to Peysina's residence to take her into custody. The suspect Parrish was present with Peysina at her residence, watching TV with her in her living room. Parrish attempted to pull Peysina back into the house prior to Your Affiant physically taking her into custody. Parrish identified himself as Peysina's attorney. As Your Affiant was placing handcuffs on Peysina, Your Affiant heard Parrish whisper to Peysina, "Remember what we talked about."
- 14. During follow-up interviews with the victim, she stated that several days after the attack, she had to meet with Parrish to discuss business matters, as they have property business interests together. She met Parrish in a public place, a local restaurant. After discussing the business at hand, she asked Parrish why Peysina was at the house on the night of the attack. Parrish told the victim that he and Peysina have an arrangement; if Parrish texts Peysina and tells her that he and the victim are arguing, she will text Parrish back asking if he is OK. If Peysina does not get a response, she is to come to his location to protect and defend him. The victim thought this explanation implausible given the fact that Parrish is about 6'2" tall and weighs approximately 220 pounds, whereas Peysina, his protector, is 5'1" and weighs about 105 pounds.

Wherefore Your Affiant requests an arrest warrant be issued for Jon Douglas Parrish, for:

- False imprisonment, contrary to Florida State Statute 787.02-1a;
- Tampering with or harassing a witness, victim, or informant, contrary to Florida State
 Statute 914.22-1e;
- Domestic violence battery, contrary to Florida State Statute 784.03-1a1; 741.28(3).
