





ORDER

THIS CAUSE coming before the Court on the Petitioner's Emergency Motion to Modify Confidentiality Protective Order and Seal Court File, Supplemental Emergency Motion to Modify Confidentiality Protective Order and Seal Court File, and Emergency Motion for Entry of Order *Instante* and/or Protocol Related to Compliance with Transparency Order; both parties' appearing through their respective counsels; the Court's having jurisdiction and having reviewed said Emergency Motions, heard arguments of counsel, and being, thereby, fully advised in the premises:

IT IS HEREBY ORDERED:

1. The Court finds each of the aforementioned Emergency Motions to constitute an emergency.
2. The Petitioner's Emergency Motion to Modify Confidentiality Protective Order and Seal Court File and Supplemental Emergency Motion to Modify Confidentiality Protective Order and Seal Court File are granted, in part, as follows:
 - A. The Court further clarifies and defines its Confidentiality Protective Order of August 21, 2019, to include, among the documents and information which shall be deemed **confidential** and subject to the protections of said Confidentiality Protective Order, any and all document(s) and information that, in any way, relates to or otherwise affects the financial stability of any privately held business entity in which either party has an ownership interest.
 - B. Any order that corresponds to any confidential document(s) or information protected by the Confidentiality Protective Order of August 21, 2019, as further clarified and defined herein, shall be sealed, including, but not limited, to any order that results from, or corresponds to, any pleading or motion which contains confidential document(s) or information.
